- (1) Model of vehicle should not be of before Year: - 2015.
- (2) Vehicle should be of 'Yellow Colour'.
- (3) Vehicle should be in registered in the name of owner.
- (4) Agreement will be made on 'Non-Judicial Stamp' of Rs. 1000/- that will be borne by the owner.
- (5) Agreement period will be from 01.07.2025 till 30.06.2026. Please note, the payment will be made for only 11 months during agreement period. Hence, payment of May & June will be made only after 30.06.2026.
- (6) The school will pay agreement amount to the owner through their registered and specified Bank Account only.
- (7) TDS will be deducted (as applicable) as per norms.
- (8) The school will pay the agreed amount and fuel as per average decided in the agreement (as per the model of vehicle). **The other all responsibilities of the vehicle/s will be borne by the owner. The school will not be responsible for any other matters related to the transportation be it Staff Salary, Maintenance, Insurance, Road Tax, Fitness, Pollution, validity etc.**
- (9) In case the breakdown or drivers sudden creation of the problems or driver/khalasi is on leave, the supplementary arrangement of bus/driver/khalashi be made by the owner on time without disturbing the school's schedule. Please ensure the Un-interrupted services of transport to the school, if under agreement.
- (10) If problems arise un-necessary the school will act, as per its own norms as applicable and as be decided by the School Management **FROM TIME TO TIME.**
- (11) The period of monthly payment will be between 10<sup>th</sup> and 20<sup>th</sup> of each month.
- (12) Other terms and conditions as defined in the agreement.
